This data set contains sensitive biological resource data for manatees and bottlenose dolphins in [for] South Florida. Vector polygons in this data set represent marine mammal distributions. Species-specific abundance, seasonality, status, life history, and source information are stored in relational data tables (described below) designed to be used in conjunction with this spatial data layer. This data set comprises a portion of the ESI data for South Florida. ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil. The ESI data include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources.

Process Steps:

- 2013-04-01 00:00:00 - West Indian manatee geographic distribution, abundance, and seasonality data was provided via shapefile through a collaboration between Florida Fish and Wildlife Conservation Commission \x96 Fish and Wildlife Research Institute (FWC-FWRI), Miami-Dade Department of Environmental Resources Management, Broward County \x96 Natural Resources Planning and Management Division \x96 Marine Resources Section, Palm Beach County Department of Environmental Resources Management, and Sea to Shore Alliance. Estuarine stocks of bottlenose dolphins were mapped to coastal waters according to the concentrations reported in the National Marine Fisheries Service (NMFS) stock assessment reports. Bottlenose dolphins are mapped as present in other shelf waters in the region. The above digital and/or hardcopy sources were compiled by the project biologist to create the M_MAMMAL data layer. Depending on the type of source data, three general approaches are used for compiling the data layer: 1) information gathered during initial interviews and from hardcopy sources are compiled onto U.S. Geological Survey 1:24,000 topographic quadrangles and digitized; 2) hardcopy maps are digitized at their source scale; 3) digital data layers are evaluated and used "as is" or integrated with the hardcopy data sources. See the Lineage section for additional information on the type of source data for this data layer. The compiled ESI, biology, and human-use data are plotted onto hardcopy draft maps. Following the delivery of draft maps to the participating resource experts, a second set of interviews are conducted to review the maps. If necessary, edits to the M_MAMMAL data layer are made based on the recommendations of the resource experts, and final hardcopy maps and digital data are created.
