An ArcMap .mxd file, an ArcView 3.x ESI project, and an ESI_Viewer product for use with the MARPLOT data are also included on the distributed CDs/DVDs for ease of use of the ESI data. The database files are distributed both in the NOAA standard relational database format (see NOAA Technical Memorandum NOS O RCA 115) and in a simplified desktop flat file format. This metadata document includes information on both of these database formats.;
