This data set contains sensitive biological resource data for dolphins and manatees for the Upper Coast of Texas. Vector polygons in this data set represent marine mammal distribution. Species-specific abundance, seasonality, status, life history, and source information are stored in relational data tables (described below) designed to be used in conjunction with this spatial data layer. This data set comprises a portion of the ESI data for the Upper Coast of Texas. ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil. The ESI data include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources.

Process Steps:

- 2013-07-01 00:00:00 - Two main sources of data were used to depict marine mammal distribution and seasonality for this data layer: 1) personal interviews with resource experts from Texas Parks and Wildlife Department (TPWD) and Texas A&M University (TAMU) and 2) published and unpublished reports. The above digital and/or hardcopy sources were compiled by the project biologist to create the M_MAMMAL data layer. Depending on the type of source data, three general approaches are used for compiling the data layer: 1) information gathered during initial interviews and from hardcopy sources are compiled onto U.S. Geological Survey 1:24,000 topographic quadrangles and digitized; 2) hardcopy maps are digitized at their source scale; 3) digital data layers are evaluated and used "as is" or integrated with the hardcopy data sources. See the Lineage section for additional information on the type of source data for this data layer. The ESI, biology, and human-use data are compiled into the standard ESI digital data format. A second set of interviews with participating resource experts are conducted to review the compiled data. If necessary, edits to the M_MAMMAL data layer are made based on the recommendations of the resource experts, and final hardcopy maps and digital data are created.
