1.2. Summary description of the data:

This data set contains sensitive biological resource data for shorebirds, diving birds, raptors, waterfowl, wading birds, terns, and gulls for the Upper Coast of Texas. Vector points in this data set represent bird nests and roosts. Species-specific abundance, seasonality, status, life history, and source information are stored in relational data tables (described below) designed to be used in conjunction with this spatial data layer. This data set comprises a portion of the ESI data for the Upper Coast of Texas. ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil. The ESI data include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources. See also the BIRDS (Bird Polygons) data layer, part of the larger Upper Coast of Texas ESI database, for additional bird information.

Process Steps:

- 2013-07-01 00:00:00 - Two main sources of data were used to depict nest distribution and seasonality for this data layer: 1) personal interviews with resource experts from Texas Parks and Wildlife Department (TPWD) and U.S. Fish and Wildlife Service (USFWS); and 2) digital maps and survey data of nesting locations provided by TPWD, USFWS, and Texas State University. Survey data on locations of breeding and resident birds were provided via shapefiles and/or tabular digital data for the following species and species group: bald eagle, breeding colonies, and American oystercatcher. Point data was mostly displayed as it was received from the data providers. Processing methods for data sets that required additional processing are described in this atlas' Introduction. Data sets were supplemented with information provided in hardcopy documents and by local resource experts. The above digital and/or hardcopy sources were compiled by the project biologist to create the NESTS data layer. Depending on the type of source data, three general approaches are used for compiling the data layer: 1) information gathered during initial interviews and from hardcopy sources are compiled onto U.S. Geological Survey 1:24,000 topographic quadrangles and digitized; 2) hardcopy maps are digitized at their source scale; 3) digital data layers are evaluated and used "as is" or integrated with the hardcopy data sources. See the Lineage section for additional information on the type of source data for this data layer. The ESI, biology, and human-use data are compiled into the standard ESI digital data format. A second set of interviews with participating resource experts are conducted to review the compiled data. If necessary, edits to the NESTS data layer are made based on the recommendations of the resource experts, and final hardcopy maps and digital data are created.
