### 1.2. Summary description of the data:

This feature class resides within the BIOLOGY Feature Data Set of the Long Island Sound - 2016 ESI Geodatabase. It contains vector polygons representing BIRDS data for Long Island Sound. The study area includes Long Island Sound, tidal tributaries, freshwater streams, lakes, and land areas in New York and Connecticut. Vector polygons in this data set represent bird distributions, nesting, rafting, roosting, wintering, and migration areas, and vulnerable occurrences.

Species-specific abundance, seasonality, status, life history, and source information are stored in associated data tables (described in Entity Attribute Overview below) designed to be used in conjunction with this spatial data layer. This data set is a portion of the ESI data for Long Island Sound.

As a whole, the ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil, and include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources.

Process Steps:

- 2016-06-01 00:00:00 - Selection of Species: The 207 bird species displayed in this atlas include: alcids, diving birds, gulls, terns, passerines, pelagic birds, raptors, shorebirds, wading birds, and waterfowl. Species that are federally and state listed, and those that are considered at risk due to oil spills or other potential disasters are included. Particular focus was paid to identifying special use areas such as migratory or wintering areas, nesting sites, concentration areas, roosting areas, and vulnerable occurrences.
- 2016-06-01 00:00:00 - Colonial waterbirds, shorebirds, and wading birds: Data for this species group came primarily from US Fish and Wildlife Service, New York Natural Heritage Program, Saltmarsh Habitat and Avian Research Program, Connecticut Natural Diversity Database, International Shorebird Survey, and New York State Significant Coastal Fish and Wildlife Habitats.
- 2016-06-01 00:00:00 - Waterfowl: Data for these species came primarily from US Fish and Wildlife Service, Mid-Winter Waterfowl Survey, the US Geological Survey Compendium of Avian Occurrence Information, and New York Significant Coastal Fish and Wildlife Habitats.
- 2016-06-01 00:00:00 - Seabirds: Data on the distribution of Seabirds was primarily provided by the US Geological Survey Compendium of Avian Occurrence Information
