This data set contains sensitive biological resource data for raptors, waterbirds, and wading birds in Rhode Island. Vector points in this data set represent bird nesting sites. Species-specific abundance, seasonality, status, life history, and source information are stored in associated data tables (described below) designed to be used in conjunction with this spatial data layer. This data set is a portion of the ESI data for Massachusetts, Rhode Island. As a whole, the ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil, and include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources. See also the BIRDS (Bird Polygons) data layer for additional bird information.

Process Steps:

- 2016-01-01 00:00:00 - GIS data for colonial waterbird nesting sites in Rhode Island were provided by RI DFW. Nest sites were observed between 1971 and 2015 and were either mapped as points or converted to polygons. Raptor nesting sites in Rhode Island were mapped either as points or converted to polygons using data from the 2015 RI Wildlife Action Plan. These nest sites do not necessarily represent all eagle or osprey nest locations in Rhode Island seacoast area but are known active nest sites. Additional nest locations for areas in Massachusetts and Rhode Island are included as polygons in the BIRDS (Bird Polygon) data layer. (Citation: 2015 RHODE ISLAND WILDLIFE ACTION PLAN)
