### 1.1. Name of the Data, data collection Project, or data-producing Program:

Massachusetts and Rhode Island 2016 HABITATS (Habitats Polygons)

### 1.2. Summary description of the data:

This data set contains sensitive biological resource data for rare plant species and vernal pools in Massachusetts and Rhode Island. Vector polygons in this data set were primarily derived from 2016 RI DEM Natural Heritage Areas and 2016 MADFW NHESP data. Species-specific abundance, seasonality, status, life history, and source information are stored in associated data tables (described below) designed to be used in conjunction with this spatial data layer. This data set is a portion of the ESI data for Massachusetts, Rhode Island. As a whole, the ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil, and include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources.

Process Steps:

- 2016-01-01 00:00:00 - Plants in Rhode Island were mapped as polygons using 2016 RI DEM Natural Heritage Areas data. All features were clipped to land and assigned the mapping qualifier of “Vulnerable Occurrence.” The Natural Heritage data includes 147 state-listed rare, endangered, and threatened species that are located in the Rhode Island AOI. All were assigned to one of four species groups in the atlas: “Endangered plant”, “Threatened plant”, “Rare plant” or “Rare wetland/aquatic plant” (includes FAV), except for the seaside sandplant (*Honckenya peploides*), which was mapped individually due to additional expert input provided by Nick Ernst, USFWS, Rhode Island National Wildlife Refuge Complex. Plants in Massachusetts were mapped using a single dataset provided by MADFW NHESP consisting of ten coastal and estuarine plant species that depend on the dynamic interface of land and water that changes on the coast with regularity. The areas of these data located on land were mapped as “Rare plant” with the mapping qualifier “Vulnerable Occurrence”. Rare plant species and communities in Massachusetts were not included in their entirety in this atlas due to vulnerability of collection concerns by NHESP. NHESP should be contacted directly for up-to-date information or review of specific locations. Vernal pools were mapped as points in Massachusetts with the mapping qualifier “Vulnerable Occurrence” using the 2016 MADFW NHESP Certified Vernal Pools dataset. This data layer contains points for all vernal pools that have been certified by NHESP and is continually updated. Data for vernal pools in Rhode Island was not available. RI DFW should be contacted directly for up-to-date information and specific locations.
