This data set contains sensitive biological resource data for federally and/or state endangered and threatened plants and rare state plants in Northwest Peninsular Florida. Vector polygons in this data set represent federally and/or state endangered and threatened plants and rare state plant occurrences. Species-specific abundance, seasonality, status, life history, and source information are stored in associated data tables (described below) designed to be used in conjunction with this spatial data layer. This data set is a portion of the ESI data for Northwest Peninsular Florida. As a whole, the ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil, and include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources.

Process Steps:

- 2016-12-01 00:00:00 - Endangered, threatened, and rare plant species were mapped with data from the FNAI and were given the mapping qualifier "Vulnerable Occurrence". Plants which have both a federal and state listing status of endangered were mapped under the name "Federally endangered plant". Plants which had no federal listing, but had a state listing of endangered or threatened were mapped as "Endangered plant" or "Threatened plant", respectively. Terrestrial plants which had a federal listing of threatened but a state listing of endangered were mapped as "Threatened terrestrial plant". Plants included without a federal or state listing were lumped as "Rare plant". Plant data sensitivities were already included in the FNAI data set.
