This data set contains vector polygons depicting locations for counties, EPA regions, Army Corps of Engineers areas, and FEMA regions, and lines depicting state water boundaries in North Carolina. Location-specific type and source information are stored in associated data tables (described below) designed to be used in conjunction with this spatial data layer. This data set is a portion of the ESI data for North Carolina. As a whole, the ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil, and include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources. See also the PARKS/MANAGED AREAS (POINTS and POLYGONS), NAVIGATION/MARINE (POINTS and POLYGONS), POLITICAL/JURISDICTIONAL (LINES and POLYGONS), RESOURCE MANAGEMENT (POINTS and POLYGONS), and NAT_HAZARD (POLYGONS) data layers for additional human-use information.

- 2016-11-01 00:00:00 - The main sources of data used to depict human-use resources for this data layer were publicly-available digital data supplemented with expert knowledge. U.S. Army Corps of Engineers (USACE) districts and divisions data were provided from the U.S. Army Engineer Research and Development Center. U.S. Coast Guard (USCG) stations were provided by the USCG and USACE. USCG district boundaries were provided by the USCG. Boundaries for counties were downloaded from the N.C. Department of Transportation (NCDOT). Jurisdictional region boundaries were provided by the U.S. Environmental Protection Agency (EPA). Jurisdictional region boundaries were provided by the Federal Emergency Management Agency (FEMA) Mapping and Analysis Center. The N.C. state waters boundary was obtained from the Bureau of Ocean Management, Regulation and Enforcement, Mapping and Boundary Branch.
