1.2. Summary description of the data:

This data set contains vector polygons depicting locations of U.S. Army Corps of Engineers (USACE) districts, U.S. Coast Guard (USCG) districts, county boundaries, Environmental Protection Agency (EPA) jurisdictional region boundaries, Federal Emergency Management Agency (FEMA) Region boundaries, state waters, and tribal lands; vector lines showing state boundaries; and vector points showing locations of coast guard stations in Chesapeake Bay and the Outer Coasts of Maryland and Virginia.

As a whole, the ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil, and include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources. The entirety of the ESI Human-Use data layers consists of: PARKS-MANAGED AREAS Polygons, Points; NAVIGATION-MARINE Polygons, Points, Lines; POLITICAL-JURISDICTIONAL Polygons, Points, Lines; RESOURCE MANAGEMENT Polygons, Points; SOCECON Polygons, Points, Lines; and NATURAL HAZARD Polygons.

Process Steps:

- 2016-09-01 00:00:00 - This atlas is the second edition of two separate first edition atlases, Virginia (2005, #25) and Maryland (2007, #47). U.S. Army Corps of Engineers (USACE) districts and divisions data were provided from the geospatial platform maintained by USACE. U.S. Coast Guard (USCG) polygonal district boundaries were provided by the USCG. County boundaries were downloaded from the U.S. Census Bureau MAF/TIGER (Topologically Integrated Geographic Encoding and Referencing) geographic database. Environmental Protection Agency (EPA) jurisdictional region boundaries were provided by the EPA. Federal Emergency Management Agency (FEMA) jurisdictional region boundaries were provided by FEMA. State jurisdictional waters (low water mark extending 3 nm offshore) were derived from the Marine Cadastre, Coastal Zone Management Act offshore boundary. Tribal lands were downloaded from the U.S. Census Bureau's Census MAF/TIGER database. The above digital and/or hardcopy sources were compiled by the project biologist to create the POLITICAL_POLY data layer. Due to imagery inconsistencies and data precision the spatial accuracy of socioeconomic point data could appear skewed. U.S. Coast Guard (USCG) stations were provided by the U.S. Coast Guard (USCG) and the U.S. Army Corps of Engineers (USACE). These data were compiled by the project biologist to create the POLITICAL_POINT data layer. State Borders were compiled from a variety of sources and verified by Research Planning, Inc. to create the POLITICAL_LINE data layer. Depending on the type of source data, three general approaches are used for compiling the data layer: 1) information gathered during initial interviews and from hardcopy sources are compiled onto U.S. Geological Survey 1:24,000 topographic quadrangles and digitized; 2) hardcopy maps are digitized at their source scale; 3) digital data layers are evaluated and used "as is" or integrated with the hardcopy data sources. See the Lineage section for additional information on the type of source data for this data layer. The ESI, biology, and human-use data are compiled into the standard ESI digital data format. A second set of interviews with participating resource experts are conducted to review the compiled data. If necessary, edits to the POLITICAL_POLY data layer are made based on the recommendations of the resource experts, and final hardcopy maps and digital data are created.
