1.2. Summary description of the data:

This data set contains sensitive biological resource data for seals, whales, dolphins, porpoises, sea otters and manatees for Chesapeake Bay and the Outer Coasts of Maryland and Virginia. Vector polygons in this data set represent marine mammal distribution and haul-out sites. Species specific abundance, seasonality, status, life history, and source information are stored in relational data tables (described below) designed to be used in conjunction with this spatial data layer. This data set comprises a portion of the ESI data for Chesapeake Bay and the Outer Coasts of Maryland and Virginia. ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil. The ESI data include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources.

Lineage Statement:

This atlas supersedes two separate first edition atlases, Virginia (2005, #25) and Maryland (2007, #47).

Process Steps:

- 2016-09-01 00:00:00 - Marine mammals depicted in this atlas include whales, dolphins, seals, sea otters and manatees. Species that are federally and state listed, and those that are vulnerable to oiling and response activities, are specifically emphasized. Marine mammal occurrence and seasonality information displayed in this atlas are based on spatial data from the Ocean Biogeographic Information System (OBIS) and Global Biodiversity Information Facility (GBIF), NOAA Fisheries Marine Mammal Stock Assessment Reports (SARS), scientific publications and expert knowledge. All spatial distributions for marine mammals depicted in this ESI were systematically reviewed by scientists and resource experts from Virginia Aquarium and Marine Science Center.
- 2016-09-01 00:00:00 - The above digital and/or hardcopy sources were compiled by the project biologist to create the MARINE MAMMAL data layer. Depending on the type of source data, three general approaches are used for compiling the data layer: 1) information gathered during initial interviews and from hardcopy sources are compiled onto U.S. Geological Survey 1:24,000 topographic quadrangles and digitized; 2) hardcopy maps are digitized at their source scale; 3) digital data layers are evaluated and used "as is" or integrated with the hardcopy data sources. See the Lineage section for additional information on the type of source data for this data layer. The ESI, biology, and human-use data are compiled into the standard ESI digital data format. A second set of interviews with participating resource experts are conducted to review the compiled data. If necessary, edits to the M_MAMMAL data layer are made based on the recommendations of the resource experts, and final hardcopy maps and digital data are created.
