### 1.2. Summary description of the data:

This data set contains sensitive biological resource data for Sargassum in Louisiana. Vector polygons in this data set represent areas of known Sargassum aggregation. Species specific abundance, seasonality, status, life history, and source information are stored in relational data tables (described below) designed to be used in conjunction with this spatial data layer. This data set comprises a portion of the ESI data for Louisiana. ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil. The ESI data include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources. See also the BENTHIC data layer, part of the larger Louisiana ESI database, for additional habitat information.

**Process Steps:**

- 2013-12-01 00:00:00 - The mapping extent was dependent upon information availability and location of mapped coastal habitats and shorelines. Polygons depicting the seasonal distribution of Sargassum were provided by Ocean Conservancy and are based on remote sensing work by Gower and King (2011). Based on their analysis, Sargassum aggregations appear in the spring offshore of Texas and move west throughout the gulf during the summer. Their analysis was based on data with a 1200m resolution, as a result, smaller aggregations of Sargassum may not have been detected. The above digital and/or hardcopy sources were compiled by the project biologist to create the HABITATS data layer. Depending on the type of source data, three general approaches are used for compiling the data layer: 1) information gathered during initial interviews and from hardcopy sources are compiled onto U.S. Geological Survey 1:24,000 topographic quadrangles and digitized; 2) hardcopy maps are digitized at their source scale; 3) digital data layers are evaluated and used "as is" or integrated with the hardcopy data sources. See the Lineage section for additional information on the type of source data for this data layer. The ESI, biology, and human-use data are compiled into the standard ESI digital data format. A second set of interviews with participating resource experts are conducted to review the compiled data. If necessary, edits to the HABITATS data layer are made based on the recommendations of the resource experts, and final hardcopy maps and digital data are created.
