1.2. Summary description of the data:

These feature classes reside within the BIOLOGY Feature Data Set of the St Marys River - 2021 ESI Geodatabase. It contains vector polygons and points representing BENTHIC data for the Great Lakes St Marys River System.

The study area includes the St. Marys River at the southern portion of Lake Superior beginning just east of Monocle Lake and south of Iroquois Island ending to the headwaters of Lake Huron. This data set contains sensitive biological resource data for submerged aquatic vegetation (SAV). Vector polygons and points in these datasets represent SAV.

Species-specific abundance, seasonality, status, life history, and source information are stored in associated data tables (described in Entity Attribute Overview below) designed to be used in conjunction with this spatial data layer. This data set is a portion of the ESI data for the Great Lakes St. Marys River System.

As a whole, the ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil, and include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources.

Process Steps:

- 2021-07-01 00:00:00 - The main sources of data that were used to depict SAV distribution and seasonality for BENTHIC & BENTHICPT data layers include: 1) a St. Marys River coastal habitat scoping report from Environment Canada, 2) seasonality information from a field guide of underwater plants in the Great Lakes, and 3) digital data from the Central Michigan University Coastal Wetland Monitoring Program. Benthic habitats mapped in the ESI atlas include submerged aquatic vegetation (SAV). SAV areas identified in an Environment Canada coastal wetland habitat scoping report were mapped as polygons. SAV point locations were mapped from the Central Michigan University Coastal Wetland Monitoring Program. No exhaustive SAV mapping data that covered the entire St. Marys River were available. Points and areas mapped in this atlas indicate locations of known presence, but other SAV areas may exist as well.
- 2021-07-01 00:00:00 - Depending on the type of source data, three general approaches are used for compiling the data layers: 1) information gathered during initial interviews and from hardcopy sources are compiled onto U.S. Geological Survey 1:40,000 topographic quadrangles and digitized; 2) hardcopy maps are digitized at their source scale; 3) digital data layers are evaluated and used "as is" or integrated with the hardcopy data sources. A second set of interviews with participating resource experts are conducted to review the compiled data. If necessary, edits to the BENTHIC & BENTHICPT data layers are made based on the recommendations of the resource experts, and final hardcopy maps and digital data are created.
