## **1. General Description of Data to be Managed**

### **1.2. Summary description of the data:**

This feature class resides within the BIOLOGY Feature Data Set of the Great Lakes - St. Clair / Detroit River System - 2019 ESI Geodatabase. It contains vector polygons representing HABITATS data for the St. Clair / Detroit River System in southeastern Michigan.

The study area includes a small portion of southern Lake Huron at its outlet, the St. Clair River (which flows out of Lake Huron), Lake St. Clair, the Detroit River (which flows into Lake Erie), a small portion of western Lake Erie, and adjacent lands and waters. This data set contains sensitive biological resource data for threatened and endangered plants. Vector polygons in this data set represent threatened and endangered plant distributions.

Species-specific abundance, seasonality, status, life history, and source information are stored in associated data tables (described in Entity Attribute Overview below) designed to be used in conjunction with this spatial data layer. This data set is a portion of the ESI data for the Great Lakes - St. Clair / Detroit River System.

As a whole, the ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil, and include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources.

##### Lineage Statement:

Sources and Process Steps cited below in this metadata record include those used for two distinct areas of the Great Lakes: the Straits of Mackinac in northern Michigan, and the St. Clair / Detroit River System in southeastern Michigan. This is because these two study areas were initially combined into a single ArcGIS geodatabase, before being separated for publication. As a final procedural step to prepare the geodatabases for publication, the spatial data data corresponding to each respective area were clipped in ArcGIS according to the two distinct geographic study areas.

##### Process Steps:

- 2019-09-23 00:00:00 - Two main sources of data were used to depict habitat distribution and seasonality for the HABITATS data layer: 1) Biotics database from Michigan Natural Features Inventory (MNFI) and 2) personal interviews with resource experts from U.S. Fish and Wildlife Service (USFWS). Data for rare plants was provided by MNFI in the Biotics database. Only state and federally listed plants were mapped in the ESI, and species names were generalized according to their status. State listed species were mapped as “Endangered plant” or “Threatened plant”, and federally listed plants were mapped as “Federally endangered plant” or “Federally threatened plant”. Occurrences of giant arrowhead in Detroit River International Wildlife Refuge were provided through personal communication with USFWS staff.
- 2019-09-23 00:00:00 - The above digital and/or hardcopy sources were compiled by the project biologist to create the HABITATS data layer. Depending on the type of source data, three general approaches are used for compiling the data layer: 1) information gathered during initial interviews and from hardcopy sources are compiled onto U.S. Geological Survey 1:50,000 topographic quadrangles and digitized; 2) hardcopy maps are digitized at their source scale; 3) digital data layers are evaluated and used "as is" or integrated with the hardcopy data sources. See the Lineage section for additional information on the type of source data for this data layer. The ESI, biology, and human-use data are compiled into the standard ESI digital data format. A second set of interviews with participating resource experts are conducted to review the compiled data. If necessary, edits to the HABITATS data layer are made based on the recommendations of the resource experts, and final hardcopy maps and digital data are created.
