1.2. Summary description of the data:

These feature classes reside within the SOCECON Feature Data Set of the Great Lakes - St. Clair / Detroit River System 2019 ESI geodatabase. They contain vector polygons, lines and points representing navigation/marine area resource data for the St. Clair / Detroit River System in southeastern Michigan.

The study area includes a small portion of southern Lake Huron at its outlet, the St. Clair River (which flows out of Lake Huron), Lake St. Clair, the Detroit River (which flows into Lake Erie), a small portion of western Lake Erie, and adjacent lands and waters.

These data sets contain information about the following resources: POLYLINES - ferry routes; POINTS- boat ramps, ferries, lock and dams, marinas, and ports; POLYGONS- access sites and anchorages.

Object specific Type and Source information are stored in the related data tables, SOC_DAT and SOURCES (described below). These are stand-alone tables within the Geodatabase, designed to be used in conjunction with these spatial data layers.

This data set is a portion of the ESI data for the St. Clair / Detroit River System. As a whole, the ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil, and include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources.

Sources and Process Steps cited below in this metadata record include those used for two distinct areas of the Great Lakes: the Straits of Mackinac in northern Michigan, and the St. Clair / Detroit River System in southeastern Michigan. This is because these two study areas were initially combined into a single ArcGIS geodatabase, before being separated for publication. As a final procedural step to prepare the geodatabases for publication, the spatial data corresponding to each respective area were clipped in ArcGIS according to the two distinct geographic study areas.

Process Steps:

- 2019-09-23 00:00:00 - Information on Navigation/Marine features within the GL_Mackinac_StClair_Detroit_River 2019 ESI study region were acquired from multiple sources. Navigation/Marine features represented as points include: boat ramps (BR), ferries (F), lock and dams (LD), marinas (M), and ports (PT). Features represented as polylines include ferry routes (FR). Features represented as polygons include: access sites (A2) and anchorages (AN).
- 2019-09-23 00:00:00 - These data were developed as NAV_MARINE_POINT, NAV_MARINE_LINE, NAV_MARINE_POLY feature classes within the GL_Mackinac_StClair_Detroit_River 2019 ESI, following ESI Guidelines. Additional data are contained in the joined table SOC_DAT using HUNUM as a unique ID, and in SOURCES using SOURCE_ID as a unique ID. Depending on the type of source data, three general approaches are used for compiling the data layer: 1) information gathered during initial interviews and from hardcopy sources are compiled onto U. S. Geological Survey 1:50,000 topographic quadrangles and digitized; 2) hardcopy maps are digitized at their source scale; 3) digital data layers are evaluated and used "as is" or integrated with the hardcopy data sources. See the Lineage section for additional information on the type of source data for this data layer. The ESI, biology, and human-use data are compiled into the standard ESI digital data format. A second set of interviews with participating resource experts are conducted to review the compiled data. If necessary, edits to the NAV_MARINE_POINT, NAV_MARINE_LINE, or NAV_MARINE_POLY data layers are made based on the recommendations of the resource experts, and final hardcopy maps and digital data are created.

- 2019-09-23 00:00:00 - Five main data sources that were used to depict human-use resources for the NAV_MARINE_POINT data layer were: 1) Google Earth 2) Michigan Department of Environmental Quality (MIDEQ) 3) personal interviews with resource experts from the Michigan Department of Natural Resources (MIDNR) 4) The National Map of the U.S. and 5) U.S. Department of Transportation (USDOT) Bureau of Transportation Statistics (BTS). All data provided were digital vector point datasets.

- 2019-09-23 00:00:00 - Two main data sources that were used to depict human-use resources for the NAV_MARINE_POLY data layer were: 1) personal interviews with resource experts from Michigan Department of Natural Resources (MIDNR) and 2) NOAA Office of Coastal Management. All data provided were digital vector polygon datasets.

- 2019-09-23 00:00:00 - The main data source that was used to depict human-use resources for the NAV_MARINE_LINE data layer was digital vector polyline data obtained from the National Map. Supplemental data digitization was conducted by Research Planning, Inc. using Environmental Systems Research Institute (ESRI) Basemap Imagery from 2019.

- 2020-09-30 00:00:00 - Sources and Process Steps cited above in this metadata record include those used for two distinct areas of the Great Lakes: the Straits of Mackinac in northern Michigan, and the St. Clair / Detroit River System in southeastern Michigan.
