### **1.2. Summary description of the data:**

This feature class resides within the SOCECON Feature Data Set of the Great Lakes Straits of Mackinac and the St. Clair Detroit River System 2019 ESI geodatabase. It contains vector polygons representing parks and managed areas resource data for the Great Lakes - Straits of Mackinac study area. The study area includes the Straits of Mackinac, nearby portions of Lake Michigan and Lake Huron, and adjacent lands and waters in northern Michigan.

These data sets contain information about the following resources: POLYGONS - national forests, management areas, military installations, marine sanctuaries, nature conservancy lands, national parks, state and local parks, state protected areas, and wildlife refuges.

Object specific Type and Source information are stored in the related data tables, SOC\_DAT and SOURCES (described below). These are stand-alone tables within the Geodatabase, designed to be used in conjunction with these spatial data layers.

This data set is a portion of the ESI data for Great Lakes - Straits of Mackinac study area. As a whole, the ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil, and include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources.

Sources and Process Steps cited below in this metadata record include those used for two distinct areas of the Great Lakes: the Straits of Mackinac in northern Michigan, and the St. Clair / Detroit River System in southeastern Michigan. This is because these two study areas were initially combined into a single ArcGIS geodatabase, before being separated for publication. Some sources may pertain to both study areas, while others may pertain to one study area and not the other. As a final procedural step to prepare the geodatabases for publication, the spatial data data corresponding to each respective area were clipped in ArcGIS according to the two distinct geographic study areas.

Process Steps:

- 2019-09-23 00:00:00 - Information on Parks/Managed area features within the GL\_Mackinac\_StClair\_Detroit\_River 2019 ESI study region were acquired from multiple sources. Parks/Managed Area features represented as points and polylines include: habitat restoration management areas (MA). Features represented as polygons include: national forests (FO), management areas (MA), military installations (MI), marine sanctuaries (MS), nature conservancy lands (NC), national parks (NP), state and local parks (P), state protected areas (SPA), and wildlife refuges (WR).
- 2019-09-23 00:00:00 - These data were developed as MANAGED\_POINT, MANAGED\_LINE, and MANAGED\_POLYGON feature classes within the GL\_Mackinac\_StClair\_Detroit\_River 2019 ESI, following ESI Guidelines. Additional data are contained in the joined table SOC\_DAT using HUNUM as a unique ID, and in SOURCES using SOURCE\_ID as a unique ID. Depending on the type of source data, three general approaches are used for compiling the data layers: 1) information gathered during initial interviews and from hardcopy sources are compiled onto U. S. Geological Survey 1:50,000 topographic quadrangles and digitized; 2) hardcopy maps are digitized at their source scale; 3) digital data layers are evaluated and used "as is" or integrated with the hardcopy data sources. See the Lineage section for additional information on the type of source data for this data layer. The ESI, biology, and human-use data are compiled into the standard ESI digital data format. A second set of interviews with participating resource experts are conducted to review the compiled data. If necessary, edits to the MANAGED\_POINT, MANAGED\_LINE, or MANAGED\_POLY data layers are made based on the recommendations of the resource experts, and final hardcopy maps and digital data

are created.

- 2019-09-23 00:00:00 - The main data source that was used to depict human-use resources for the MANAGED\_LINE and MANAGED\_POINT data layers was a personal interview with a resource expert from the U.S. Environmental Protection Agency (USEPA). The expert provided us with digital vector polyline and point data depicting managed habitat restoration sites.

- 2019-09-23 00:00:00 - The main data sources that were used to depict human-use resources for the MANAGED\_POLY data layer were: 1) Great Lakes Aquatic Habitat Framework (GLAHF) 2) Michigan Department of Natural Resources (MIDNR) 3) NOAA Office of National Marine Sanctuaries 4) The Nature Conservancy (TNC) 5) U. S. Census Bureau (USCB) 6) U.S. Department of Agriculture Forest Service (USDA FS) 7) a personal interview with a resource expert from the U.S. Environmental Protection Agency (USEPA) 8) U.S. Fish and Wildlife Service (USFWS) and the 9) National Park Service (NPS). All data provided were digital vector polygon datasets.
