- 2021-07-01 00:00:00 - The main source of data used to depict terrestrial mammal distribution for this data layer was Element Occurrence digital data provided by MNFI. The above digital and/or hardcopy sources were compiled by the project biologist to create the T_MAMMAL data layer. Depending on the type of source data, three general approaches are used for compiling the data layer: 1) information gathered during initial interviews and from hardcopy sources are compiled onto U. S. Geological Survey 1:40,000 topographic quadrangles and digitized; 2) hardcopy maps are digitized at their source scale; 3) digital data layers are evaluated and used "as is" or integrated with the hardcopy data sources. A second set of interviews with participating resource experts are conducted to review the compiled data.
