1.2. Summary description of the data:

This feature class resides within the BIOLOGY Feature Data Set of the St Lawrence River - 2021 ESI Geodatabase. It contains vector polygons representing BENTHIC data for the Great Lakes St Lawrence River.

The study area includes the St. Lawrence River from the headwaters of Lake Ontario, northeast to the western portion of L'Ile-Saint-Regis Island (CA). This data set contains sensitive biological resource data for submerged aquatic vegetation (SAV). Vector polygons in this dataset represent SAV.

Species-specific abundance, seasonality, status, life history, and source information are stored in associated data tables (described in Entity Attribute Overview below) designed to be used in conjunction with this spatial data layer. This data set is a portion of the ESI data for the Great Lakes St. Lawrence River.

As a whole, the ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil, and include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources.

Process Steps:

- 2021-07-01 00:00:00 - Two main sources of data were used to depict SAV distribution and seasonality for this BENTHIC data layer: 1) digital habitat data from the New York State Department of State Significant Coastal Fish and Wildlife Habitats dataset and 2) published and unpublished documents. Benthic habitats mapped in the ESI atlas include submerged aquatic vegetation (SAV). SAV areas were mapped from the New York State Department of State Significant Coastal Fish and Wildlife Habitats dataset. Additional areas identified in a NYPA and Environnement Illimité, Inc. habitat assessment report were also mapped. No exhaustive SAV mapping data that covered the entire St. Lawrence River were available. Areas mapped in this atlas indicate areas of known presence, but other SAV areas may exist as well.

- 2021-07-01 00:00:00 - Depending on the type of source data, three general approaches are used for compiling the data layers: 1) information gathered during initial interviews and from hardcopy sources are compiled onto U.S. Geological Survey 1:40,000 topographic quadrangles and digitized; 2) hardcopy maps are digitized at their source scale; 3) digital data layers are evaluated and used "as is" or integrated with the hardcopy data sources. A second set of interviews with participating resource experts are conducted to review the compiled data. If necessary, edits to the BENTHIC data layer is made based on the recommendations of the resource experts, and final hardcopy maps and digital data are created.
