1.2. Summary description of the data:

These feature classes reside within the BIOLOGY Feature Data Set of the St Lawrence River - 2021 ESI Geodatabase. It contains vector polygons and points representing BIRDS data for the Great Lakes St Lawrence River.

The study area includes the St. Lawrence River from the headwaters of Lake Ontario, northeast to the western portion of L'Ile-Saint-Regis Island (CA). This data set contains sensitive biological resource data for wading birds, shorebirds, waterfowl, raptors, diving birds, passerine birds, and gulls and terns in the St. Lawrence River.

Species-specific abundance, seasonality, status, life history, and source information are stored in associated data tables (described in Entity Attribute Overview below) designed to be used in conjunction with this spatial data layer. This data set is a portion of the ESI data for the Great Lakes St. Lawrence River.

As a whole, the ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil, and include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources.

Process Steps:

- 2021-07-01 00:00:00 - Three main sources of data were used to depict bird distribution and seasonality for these data layers (BIRDS & BIRDSPT): 1) personal interviews with resource experts from NYS DEC, U. of Minnesota, Riveredge Environmental, and NY NHP, SUNY - ESF, 2) vector digital data sets provided by NYS DEC, NY NHP, SUNY - ESF, Division of Fish, Wildlife, and Marine Resources Bureau, and 3) published and unpublished reports, maps, and survey data from the above and eBird.

- 2021-07-01 00:00:00 - Depending on the type of source data, three general approaches are used for compiling the data layer: 1) information gathered during initial interviews and from hardcopy sources are compiled onto U.S. Geological Survey 1:40,000 topographic quadrangles and digitized; 2) hardcopy maps are digitized at their source scale; 3) digital data layers are evaluated and used "as is" or integrated with the hardcopy data sources. The ESI, biology, and human-use data are compiled into the standard ESI digital data format. A second set of interviews with participating resource experts are conducted to review the compiled data. If necessary, edits to the BIRDS & BIRDSPT data layers are made based on the recommendations of the resource experts, and final hardcopy maps and digital data are created.
