This feature class resides within the BIOLOGY Feature Data Set of the Lake Erie - 2022 ESI Geodatabase. It contains vector polygons representing BENTHIC data for Lake Erie.

The study area includes the United States portion of Lake Erie, covering the coastal portions of Ohio, Pennsylvania, and New York from the Michigan/Ohio border to the west to the New York/Canada border to the east. This data set contains sensitive biological resource data for submerged aquatic vegetation (SAV). Vector polygons in this dataset represent SAV distribution.

Species-specific abundance, seasonality, status, life history, and source information are stored in associated data tables (described in Entity Attribute Overview below) designed to be used in conjunction with this spatial data layer. This data set comprises a portion of the ESI data for Lake Erie.

As a whole, the ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil, and include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources.

- 2022-08-01 00:00:00 Two main sources of data were used to depict SAV distribution and seasonality for this BENTHIC data layer: 1) digital data from Michigan Tech Research Institute (MTRI) and New York State Department of Environmental Conservation (NYSDEC) and 2) personal interviews with resource experts from NYSDEC. SAV data for Lake Erie was provided by MTRI. In the MTRI dataset, areas that were attributed as "less dense SAV" or "dense SAV" were combined, and these areas were used to map SAV presence. Due to the high resolution of the MTRI data, data were buffered by 20 m and smoothed by 50 meters to create the final SAV areas. SAV in Lake Erie is predominantly Cladophora, a nuisance, native green alga. Mapped areas also include other SAV, including vascular plants, other filamentous algae, and diatoms. SAV data for the Niagara River was provided by NYSDEC. Areas that were attributed as "Patchy" or "Continuous" were combined to map SAV presence.
- 2022-08-01 00:00:00 Depending on the type of source data, three general approaches are used for compiling this data layer: 1) information gathered during initial interviews and from hardcopy sources are compiled onto U.S. Geological Survey 1:42,000 topographic quadrangles and digitized; 2) hardcopy maps are digitized at their source scale; 3) digital data layers are evaluated and used "as is" or integrated with the hardcopy data sources.
