They contain vector polygons and points representing Socioeconomic human-use resource data for Lake Erie and adjacent lands and waters. The study area includes the United States portion of Lake Erie, covering the coastal portions of Ohio, Pennsylvania, and New York from the Michigan/Ohio border to the west to the New York/Canada border to the east.

These data sets contain information about the following resources: National Register of Historic Places historical sites, beaches, and heliports in Lake Erie.

Object specific Type and Source information are stored in the related data tables, SOC\_DAT and SOURCES (described below). These are stand-alone tables within the Geodatabase, designed to be used in conjunction with these spatial data layers.
