This feature class resides within the SOCECON Feature Data Set of the Lake Erie 2022 ESI Geodatabase. It contains vector points representing Navigational/marine human-use resource data for the Lake Erie System and adjacent lands and waters. The study area includes the United States portion of Lake Erie, covering the coastal portions of Ohio, Pennsylvania, and New York from the Michigan/Ohio border to the west to the New York/Canada border to the east.

This data set contains information about the following resources: access points, anchorages, boat ramps, ferry terminals, lock and dams, marinas, and ports in Lake Erie.

Object specific Type and Source information are stored in the related data tables, SOC\_DAT and SOURCES (described below). These are stand-alone tables within the Geodatabase, designed to be used in conjunction with these spatial data layers.

Vehicular and/or foot beach access points were provided by the Pennsylvania Fish and Boat Commission as well as the Ohio Department of Natural Resources. Locations where commercial vessels can be anchored offshore were provided by the NOAA's Office of Coastal Survey. Designated public boat ramps were provided by the New York State Department of Environmental Conservation, the Pennsylvania Fish and Boat Commission, as well as the Ohio Department of Natural Resources. Ferry terminal locations were obtained from the U.S. Department of Transportation, Bureau of Transportation Statistics. Data showing the inventory of dams were provided by U.S. Army Corps of Engineers. Marina locations were provided by Ohio Department of Natural Resources in conjunction with Google Map location.
