In the MTRI dataset, areas that were attributed as "less dense SAV" or "dense SAV" were combined, and these areas were used to map SAV presence. Due to the high resolution of the MTRI data, data were buffered by 20 m and smoothed by 50 m to create the final SAV areas. SAV in Lake Ontario is predominantly Cladophora, a nuisance, native green alga. Mapped areas also include other SAV, including vascular plants, other filamentous algae, and diatoms.
