- 2023-08-15 00:00:00 Digital data were used to depict management areas for the MANAGED_POLY data layer. A total of 13 management areas including wildlife management areas and state forests were provided by the New York State Department of Environmental Conservation. State Park boundaries were downloaded from the New York State Office of Parks, Recreation, and Historic Preservation. Boundaries depicting Nature Conservancy properties were obtained from the TNC Lands database.
- 2023-08-15 00:00:00 The above digital and/or hardcopy sources were compiled by the project biologist to create the MANAGED_POLY data layer. Depending on the type of source data, three general approaches are used for compiling the data layer: 1) information gathered during initial interviews and from hardcopy sources are compiled onto U.S. Geological Survey 1:42,000 topographic quadrangles and digitized; 2) hardcopy maps are digitized at their source scale; 3) digital data layers are evaluated and used "as is" or integrated with the hardcopy data sources.
