## **1. General Description of Data to be Managed**

### **1.2. Summary description of the data:**

These feature classes reside within the SOCECON Feature Data Set of the Lake Ontario 2023 ESI Geodatabase. They contain vector lines and points representing Socioeconomic human-use resource data for Lake Ontario and adjacent lands and waters. Vector lines in this data set represent major crude oil pipelines and vector points represent human-use or management resource data for airports, beaches, heliports, and historical sites for Lake Ontario.

The study area includes the United States portion of Lake Ontario, covering the islands in New York: Association Island, Bass Island, Calf Island, Carl Island, Cherry Island, Eagle Island, Fox Island, Galloo Islands, Grenadier Island, Horse Island, Hoveys Island, Six Point Town, and Stony Island. Major Lake Ontario bays mapped include: Black River Bay, Blind Sodus Bay, Braddock Bay, Chaumont Bay, Guffin Bay, Irondequoit Bay, Henderson Bay, Little Sodus Bay, Mexico Bay, Port Bay, Sawyer Bay, and Sodus Bay.

Object specific Type and Source information are stored in the related data tables, SOC\_DAT and SOURCES (described below). These are stand-alone tables within the Geodatabase, designed to be used in conjunction with these spatial data layers.

This data set is a portion of the ESI data for the Lake Ontario System. As a whole, the ESI data characterize the marine and coastal environments and wildlife by their sensitivity to spilled oil, and include information for three main components: shoreline habitats, sensitive biological resources, and human-use resources.

Process Steps:

- 2023-08-15 00:00:00 - Digital data was used to depict human-use resources for the SOCECON\_LINE data layer downloaded from the U.S. Energy Information Association (USEIA).
- 2023-08-15 00:00:00 - The main sources of data used to depict human-use resources for the SOCECON\_POINT data layer were: 1) digital data downloaded from the United States Department of Transportation Federal Aviation Administration Aeronautical Information Services for airports and heliports, 2) Locations of recreational beaches used for activities such as swimming, sun-bathing, fishing, and various other uses located via Google maps, and 3) historical sites depicting locations that are listed on the National Register of Historic Places downloaded from the National Park Service.
- 2023-08-15 00:00:00 - The above digital and/or hardcopy sources were compiled by the project biologist to create the SOCECON\_POINT & SOCECON\_LINE data layers. Depending on the type of source data, three general approaches are used for compiling the data layer: 1) information gathered during initial interviews and from hardcopy sources are compiled onto U.S. Geological Survey 1:42,000 topographic quadrangles and digitized; 2) hardcopy maps are digitized at their source scale; 3) digital data layers are evaluated and used "as is" or integrated with the hardcopy data sources. See the Lineage section for additional information on the type of source data for this data layer. The ESI, biology, and human-use data are compiled into the standard ESI digital data format. A second set of interviews with participating resource experts are conducted to review the compiled data. If necessary, edits to the SOCECON\_POINT & SOCECON\_LINE data layers are made based on the recommendations of the resource experts, and final hardcopy maps and digital data are created.
