Meeting Highlights

Welcome / Logistics

• Facilitator, Laura Dwinnell, welcomed all attendees at10:00am AKDT, provided an announcement of meeting recording, procedures for voting by the panelist and an agenda overview.

Update on AKSRTF

• Chair, Ed Farley, provided an overview of the task force charge and duties, a timeline and milestones, a description of the knowledge review and plans to capture gaps and project ideas and an overview of the AKSRTF Report outline as the final product due in June 2024.

Region Area Updates

Southeast Region - Lead: Andy Piston

• Provided a description of the southeast region challenges and presented slide materials on Southeast Salmon Stock Assessment and Research. Described trends for Chinook, Sockeye, Coho, Chum and Pink salmon.

Westward Region - Lead: Michelle Stratton

• Described the type and quantity of the knowledge and information sources obtained thus far by the region team members. They will assess the information collected by about 31 July and hope to get interest from research coordinators in that region to provide

additional insights. About 30 articles so far covering topics such as: marine and freshwater, current status 2022 adult and smolt work, hatchery work, predator interactions etc. Described upcoming projects

Central Region - Lead: Tommy Sheridan

• Described the large and diverse area that can be separated into distinct units. Introduced the central region team members and announced the meeting that their team will have on 7/28/2023.

AYK Region - Lead: Katie Howard

 Different in scope than the other regions. Described the interplay and roles between AYK Task Force and AYK WG (composed of both all AYK task force members and public participants who requested to participate). Focus on chinook and chum in this region due to poor levels. Task Force team will be responsible for developing all written materials for the report and for synthesizing the existing knowledge. WG will elect a public co-lead. The AYK report will be a subcomponent of the AKRSTF Report. Acknowledged that not all knowledge is in traditional written format and that all forms/formats of knowledge will be welcomed and included.

AYK Working Group

- Ed Farley: Described the WG objectives (specifically the research needs of salmon returns in AYK), timeline and distinct role as a subset of the larger task force. Task Force has accepted all nominations to the WG. Provided a slide showing the list of Task Force members who are part of the WG as well as a list of the public nominees who have agreed to participate in the WG.
- Vice Chair, Jacob Ivanoff: Provided a suggested timeline of activities for the AYK WG and noted that the WG would hold their first meeting in early September. The WG co-leads will determine the date. Katie Howard will be the co-lead from the Task Force and there will be one (to be determined) co-lead from the public participants. The November 14 and 15 meeting will have both afternoon dedicated to public testimony.
