## **Announcements**

Kathy Wang provided an overview of the timeline for the development of the Take Reduction Plan as defined in the Marine Mammal Protection Act. These timelines included:

May 7, 2002: Deadline for submittal of the recommendations from the BDTRT

July 7: Publication of the Draft Proposed Rule in the *Federal Register* followed by a 90-day comment period.

October 7: End of public comment period

December 7: Publication of the Final Rule in the *Federal Register*

Jim Feldt and Hans Neuhauser reminded the team of the goal of this session – to finalize the team’s recommendations – and the meeting objectives: to develop recommendations for each management unit, to develop a list of consensus and non-consensus items and to finalize the team’s recommendations in written format.

### **Working Groups, Working Group Reports and Plenary Sessions**

During the three day meeting, working groups would report to the entire team on their progress towards achieving consensus on measures to reduce take of bottlenose dolphin. The team would then react, providing comments and asking questions. Each working group would then reconvene and continue discussions with the team’s comments in mind. This cycle of working groups, reports and responses was repeated several times over the course of the three days.

The Team submitted a consensus agreement to NMFS. The next meeting of the Take Reduction Team will take place during the public comment period on the Draft Proposed Rule, anticipated to be sometime between July 7 and October 7, 2002. As NMFS gets closer to publishing the Draft Proposed Rule in the *Federal Register*, the Team members will be polled to determine the best dates for the next TRT meeting.

In an informal opinion poll, participants in the fifth TRT meeting selected Washington, DC and Virginia Beach, Virginia as the preferred sites for the next meeting with

Savannah, Georgia third. The final selection of the site will depend on the dates selected and the availability of suitable accommodations and meeting sites.

Opportunities for public comment were provided at the end of each day's deliberations on April 23, 24 and 25. No public comment was provided.

Dear Mr. Pruitt,

At the request of the Bottlenose Dolphin Take Reduction Team we are seeking a temporary permit to demonstrate a nighttime proximity rule for vessels and gill net gear recommended as a mitigation measure to reduce bottlenose dolphin bycatch in coastal waters using webbing of 5 inches or greater.

The mitigation measure would be effective from New Jersey through North Carolina state waters. Because the team intends to implement these measures this winter, we need to demonstrate the effectiveness of the measure as soon as possible. In order to effectively demonstrate how the proximity rule might be implemented across all states and because net length requirements differ from state to state, we require the ability to set nets greater than 1200' for the purposes of this limited demonstration. The gear in question is used to prosecute the smooth dogfish fishery, which is currently active in Virginia. We hope to perform the demonstration before the end of May and must expedite the permit process. We expect that we would require less than five days of

fishing using one vessel (Chris Walker of Chincoteague has agreed to perform the demonstration).

This demonstration is requested by members of the Take Reduction Team and the National Marine Fisheries Service (see attached letters of support).
