High Seas off South America	JAN 2023	Trinidad and Tobago	Longline activity indicative of fishing for tuna-like species on high seas with no current ICCAT permit; later compliant with ICCAT vessel registry.
High Seas off South America	JAN 2023	Trinidad and Tobago	Longline activity with yellowfish and albacore tuna catch without current ICCAT permit; later compliant with ICCAT vessel registry.

- MX Fishing Vessel Port Denial.
- Serve on ICCAT U.S. Delegation to promote at-sea inspections, participate in a high seas boarding inspection seminar, act upon suspected IUU fishing sightings, foster electronic monitoring, and progress labor condition policy.

## **Strategic & Operational Emphasis- International**

- Continue to build law enforcement capacity and partnerships with other nations through:
  - Interagency Road Shows,
  - Mobile Training Branch visits, and
  - Joint patrols involving U.S. Coast Guard assets.
