- H.R. 3980 (REP. LUCAS, R-OKLAHOMA), THE "NATIONAL OCEANIC AND ATMOSPHERIC ADMINISTRATION ACT OF 2023." INCLUDES LANGUAGE TO STUDY THE TRANSFER OF ESA AND MMPA DUTIES FROM NOAA TO FWS



- THE HOUSE OF REPRESENTATIVES:
 - 4 OF THE 12 APPROPRIATIONS BILLS HAVE PASSED THE HOUSE,
 - 6 BILLS HAVE BEEN REPORTED OUT OF COMMITTEE (1 FAILED ON THE HOUSE FLOOR),
 - 2 HAVE NOT BEEN REPORTED BY THE HOUSE APPROPRIATIONS COMMITTEE COMMERCE, JUSTICE,
 SCIENCE, AND RELATED AGENCIES HAS NOT BEEN REPORTED OUT YET
- THE SENATE:
 - 0 OF THE 12 APPROPRIATIONS BILLS HAVE PASSED THE SENATE,
 - ALL 12 HAVE BEEN REPORTED OUT BY THE SENATE APPROPRIATIONS COMMITTEE



CONTINUING RESOLUTION

- FUNDS ALL FEDERAL AGENCIES THROUGH NOVEMBER 17TH
- EXTENDS FAA AUTHORIZATION THROUGH DECEMBER 31ST
- PROVIDES EMERGENCY DISASTER RELIEF
- FROM WEDNESDAY, OCTOBER 11 UNTIL NOVEMBER 17 ONLY 28 POSSIBLE LEGISLATIVE DAYS (NOT INCLUDING WEEKENDS AND THIS ASSUMES 5 DAYS OF SESSION PER WEEK)
- THE SENATE IS CURRENTLY OUT OF SESSION
- THE HOUSE CANNOT ACT ON ANY LEGISLATION UNTIL A NEW SPEAKER IS ELECTED FIRST POSSIBLE VOTE IS
 WEDNESDAY, OCTOBER 11 NOT LIKELY TO BE BROUGHT UP FOR A VOTE UNLESS 218 VOTES ARE
 GUARANTEED SECRET VOTE TAKEN BY REPUBLICAN CAUCUS
- ONE OF THE BIG ISSUES HOUSE REPUBLICANS ARE CONCERNED ABOUT IS CONSIDERING EACH APPROPRIATION BILL SEPARATELY AND WITH OPEN AMENDMENT PROCESS
