



Advance Notice of Proposed Rulemaking (ANPR) on Electronic Reporting

- ANPR published 05/12/2023; comment period ended 08/18/2023
- 11 written comments received
- Numerous oral comments received during 7 in-person and virtual public hearings, and presentations to 5 regional fishery management councils and the HMS Advisory Panel
- This action considers modifying or expanding electronic reporting requirements for HMS commercial and recreational vessel owners and dealers, consistent with the "One Stop Reporting" initiative



Summary of Public Comments on Electronic Reporting ANPR

- Some commercial and recreational fishing groups supported this rulemaking in general, while others supported maintaining status quo reporting requirements
- Overall, commenters supported electronic "One Stop Reporting"
- Commenters requested clear rationale for any changes in reporting requirements, and how data will be used for science or management
- Some commercial groups called for more equitable reporting across sectors
- Several commenters encouraged collaboration with our partners (e.g., regional offices, states, fishery management councils) or working with industry on outreach and education
- Commenters encouraged consideration of how new data streams would be calibrated with existing data, time series, and surveys
- Where are we now? Proposed rule expected later in 2024

Proposed Rule on BFT General Category Effort Controls

- Proposed rule published 02/23/2024; comment period ended 03/25/2024
- 36 written comments received
- Proposed rule would:
 - Codify every Tuesday, Friday, and Saturday as restricted-fishing days (RFDs) from July 1 through November 30 for the 2024 fishing year and subsequent years
 - Establish a General category default retention limit of 3 large medium or giant BFT for June and 1 large medium or giant BFT for all other months in time periods when the fishery is open
 - Clarify HMS dealer and dealer agent requirements on an RFD
- On an RFD, Atlantic Tunas General category permitted vessels may not fish for (including catch-and-release or tag-and-release fishing), possess, retain, land, or sell BFT
- On an RFD, HMS Charter/Headboat vessels with a commercial sale endorsement are also subject to these restrictions, but they may fish for, possess, retain, or land BFT when fishing recreationally under applicable HMS Angling category rules
- Where are we now? Final rule expected shortly



Proposed Rule on Sea Turtle Careful Release Requirements in Longline Fisheries

- Proposed rule published 04/08/2024; comment period ended 05/08/2024
- 5 written comments received
- Would update the HMS regulations regarding sea turtle safe handling and release requirements based on two technical memoranda published by the Southeast Fisheries Science Center
- Would not change any of the current operation requirements of HMS fisheries
- All previously authorized sea turtle bycatch mitigation tools and gear removal protocols remain approved for use
- Where are we now? Final rule expected later in 2024



Upcoming Rules (not being discussed later in the meeting)



Northern Albacore, Swordfish, and BFT Quotas

- Annual adjustment of baseline quotas for:
 - North Atlantic albacore tuna (northern albacore),
 - North and South Atlantic swordfish, and
 - Atlantic BFT Reserve category
- Quota adjustment for 2024 would be based on:
 - Underharvest of 2023 adjusted U.S. quotas and limitations set by ICCAT on what can be carried forward, and
 - Swordfish quota transfers, per ICCAT recommendations
- Would increase baseline quota for northern albacore in the regulations, from 711.5 mt to 889.4 mt, per ICCAT Rec. 23-05

ICCAT = International Commission for the Conservation of Atlantic Tunas



Upcoming Rule Timing:

- BFT General category effort controls *Final rule ~June*
- Amendment 15 (spatial management) Final rule ~Summer
- Electronic reporting *Proposed rule ~Summer/Fall*
- 2024 Annual swordfish, albacore, and BFT quota adjustment and albacore quota increase - *Final rule ~Summer/Fall*
- Updating Sea Turtle Safe Handling Requirements consistent with the Technical Memorandum - *Final rule ~Fall/Winter*
- Consideration of pelagic and bottom longline indicator species list -*Proposed rule ~Fall/Winter*
- Amendment 16 (sharks) *Proposed rule ~Winter/Spring*



Open Review/Comment Periods:

- Amendment 15 Spatial management Final Environmental Impact Statement (FEIS) - EPA review period ends 06/10/2024
- Gear considerations Scoping Comment period ends 07/31/2024




