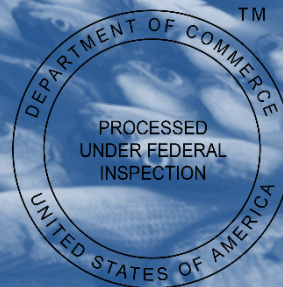

Introduction

The mission of the United States Department of Commerce Seafood Inspection Program (USDC SIP) is to ensure the safety and quality, as well as enhance the marketability and sustainability, of seafood products for the benefit of the American consumer by providing science based inspection services to the seafood industry.

The authority for the United States Department of Commerce Seafood Inspection Program to provide services can be found within the Agricultural Marketing Act of 1946, the Fish and Wildlife Act of 1956, and the regulations promulgated under these authorities (i.e., 50 CFR Part 260).

USDC SIP Approved Establishment participants are those that process products under the USDC SIP on a contract basis. Approved Establishments are included on a list published on the USDC SIP's official website. Inclusion on this list is contingent upon the organization's continued ability to maintain USDC SIP Approved Establishment requirements. Approved Establishments are verified by audit to meet all applicable federal regulations governing the construction and maintenance of facilities and equipment, processing techniques, and employer practices in the production of fishery products for human consumption. These audits evaluate the food safety and quality system by examining product, processes, and records.

To provide the user with a ready reference, the organizations are divided into two categories:

All organizations approved to produce fishery products for human consumption, which may also be eligible to bear the official USDC Inspection and/or Grade Mark with an Approved Product Management Plan.

Organizations approved for producing fishery by-products not intended for human consumption.

The organizations listed in this document, at their own expense, voluntarily contracted with USDC for inspection services. They have demonstrated their ability to meet rigid standards to produce safe, wholesome, quality fishery products. NOAA Fisheries does not infer that organizations not appearing on this list fail to meet rigid safety and quality standards. This list is a compilation of those firms participating in the National USDC Seafood Inspection Program.

Eligible products that are officially inspected may bear USDC Inspection Marks, i.e., U.S. Grade A, and/or Processed Under Federal Inspection (PUFI). Financially interested parties may request certification on products bearing or not bearing marks, which is a written report that certifies the type of inspection, class, grade, quality, size, quantity, or condition of products (including the compliance of product with applicable specifications).
